

ADDENDUM TO CONTESTANT'S

Scholarship Rules and Regulations

This addendum will become part of the original contract signed by

_____, a participant in the 2014 Miss IFOYC
Pageant.

1. If selected as the Winner of the "2014 Miss IFOYC International":

a. I understand if I choose to use the services of a coach for talent or personal grooming, I will consult with and/or obtain approval of the Pageant Committee.

- b. I will serve as “Miss IFOYC International” until my successor is selected or appointed.
- c. I will notify the Pageant Advisor of any and all requests for public appearances made as “Miss IFOYC International” or as an official representative of International Federation of Youth Conquerors Inc. The Pageant Advisor will, in effect, become the agent for “Miss IFOYC”. In addition, I will notify the Pageant Advisor in advance if I choose to compete in any other Miss Florida Preliminary pageant.
- d. I will schedule, within two weeks of being crowned, an appointment to have a portrait photo session with the pageant photographer. Final selection of the photographer and photos, to be used in the Miss IFOYC Program Book, will be approved by the Pageant Director and Committee.
- e. I will obtain approval from the Pageant Director and Committee, for the contestant fact sheet, wardrobe and talent selection prior to going to the Miss IFOYC Pageant.
- f. I will make myself available for personal appearances, interviews, testimonials, endorsements, filming, and other such commitments and events that the Pageant Committee has made or will make for me whenever said appearance does not conflict with the furtherance of my education or employment. In addition I will meet on a regular basis (weekly or bi-weekly) with the Pageant Director and/or Committee.
- g. I will make myself available to assist with, including attending committee meetings and rehearsals, the 2013 Miss IFOYC Pageant.
- h. I will attend all the events and programs of International Federation of Youth Conquerors .
- i. I will represent the International Federation of Youth Conquerors globally .

2. If selected as first or second runner-up to the title of “Miss IFOYC International”, I agree to be available to succeed to all the rights and to assume all of the duties and obligations of this title as set forth herein, if for any reason the original “Miss IFOYC International” or prior runners-up are unable or ineligible to act as “Miss IFOYC 2014”.

As a scholarship winner in the Miss IFOYC Pageant I understand and accept the scholarship regulations as outlines below:

1. Scholarships shall be expended for tuition and related expenses, such as room, board, and other educational expenses as approved by the Miss IFOYC Pageant Scholarship Committee.
2. The winner and runners-up must be currently enrolled at IFOYC at the time the scholarship is paid.
3. The winners and runners-up must be academically eligible, as required by IFOYC organization to receive a scholarship.
4. The winner must be eligible to hold the Miss IFOYC crown. She must meet all requirements set forth in the contract, as required by Miss International Federation of Youth Conquerors (IFOYC) guidelines.
5. The winner’s scholarship will be awarded over two semesters (spring and fall) in equal payments. The award amount will be credited to the winner’s academic account school.
6. The first runner-up scholarship will be awarded spring semester. The award amount will be credited to the winner’s academic account School.

7. The other runner-up scholarships will be awarded spring semester. The award amount will be credited to the winner's academic account school.

8. No cash awards will be made in lieu of scholarship.

9. Scholarships to be awarded for the 2014 Miss IFOYC Pageant include:

Winner: \$2,500.00 , Magazine full page Ad and Editorial , gifts cards . accesories and awards.

First Runner-up: \$ 1,000.00 , Magazine full page Ad and Editorial , gifts cards and awards.

Second Runner-up: \$ 500.00 , Magazine full page Ad and Editorial and awards.

The guidelines and regulations have been effective since November 8, 2013 and will continue until any changes are made by the Miss IFOYC scholarship Committee.

The Miss IFOYC Pageant Committee will provide the following additional support to the title holder of "Miss IFOYC International":

1. Miss IFOYC will be required to attend our local and out of states events. This Miss IFOYC Pageant Committee will provide transportation and lodging, as arranged by the Pageant Committee, and a reasonable allowance for meals, per IFOYC policy.
2. Miss IFOYC may be required to attend an orientation weekend meeting to be held during the spring. The program will begin early on Saturday morning and will end the same today. The Miss IFOYC Pageant will provide meals for Saturday.

The Miss IFOYC Committee will also provide reasonable reimbursement for transportation to the meeting, as approved by International Federation of Youth Conquerors Inc.

3. The Miss IFOYC Committee will provide payment for the required outfit if the Miss IFOYC Pageant opening number requires that all contestants wear the same outfit.

The Pageant Committee will have approval of the selection of the outfit.
